A Village of Stamford man has been arrested for the second time in the past year for selling heroin in that Village.

On Thursday afternoon two Village of Stamford residents were arrested by Delaware County Sheriff's Deputies and Investigators, assisted by Troopers assigned to State Police at Stamford, following an investigation conducted by the Sheriff's Office Criminal Investigation Division.

Miguel E. Santiago, 24, was arrested on a Sealed Grand Jury Indictment Warrant issued Thursday afternoon charging him with two counts of Criminal Sale of a Controlled Substance in the Third Degree, class B felonies, and one count of Endangering the Welfare of a Child, a class A misdemeanor.

Santiago is accused of selling heroin in the Village of Stamford on two occasions earlier this year.

Courtney E. Rossman, 24, was also arrested on Sealed Grand Jury Indictment Warrant issued Thursday afternoon charging her with one count of Endangering the Welfare of a Child, a class A misdemeanor.

Santiago and Rossman are each accused of Endangering the Welfare of a Child that was present during one of those heroin sales.

Rossman was also charged with Unlawful Possession of Marihuana after Deputies discovered a small quantity of marihuana in plain view within the apartment at the time of her arrest. She was issued an Appearance Ticket returnable in the Town of Harpersfield Court at a later date.

Santiago and Rossman were arraigned in Delaware County Court on Friday morning before County Court Judge Carl F. Becker where Santiago was returned to jail without bail to await future court action. Rossman was released on her own recognizance to reappear in court at a later time.

On June 14, 2013 Miguel Santiago was also arrested by Sheriff's Investigators on a Sealed Indictment Warrant charging him with two counts of Criminal Sale of a Controlled Substance in the Third Degree following a separate, unrelated, heroin trafficking investigation conducted by the Sheriff's Office Criminal Investigation Division earlier in the year. Santiago was released from the Delaware County Correctional Facility on June 21, 2013 upon the posting of \$10,000 cash bail and is currently awaiting trial relating to that arrest.
